SUBJECT: REGARDING REQUEST OF SCHOOL FOR ENHANCEMENT OF SECTIONS - REG.

Sir/Madam,

This is with reference to school application No.-IS-90037-2324 dt. on the subject cited above.

Sl. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 48 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 8 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.
Sl. No.	CONDITIONS FOR COMPLIANCE
1	1. The total number of section of the school shall be restricted to 48 (for both shifts combined) as per number of classes reported at the time of inspection. The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed. Further, increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and subject to the availability of room size of greater than 500 sq ft. The school has an authorisedly increased sections in the past. Any similar action by the school in future shall render it liable for penal action and dis affiliation for violation of affiliation bye laws.
2	The school is multi storied, but has not made any ramp/lift for CWSN to access the upper floors. The school shall construct the ramp/install a lift as per norms of RPwD Act and guidelines issued by the Board and submit compliance within 3 months on SARAS,
3	The school has converted regular cubicles into CWSN toilets, but they are too narrow and small for a wheelchair/walker to neavigate. No such toilets are seen on upper floors. The school shall properly construct separate toilets for CWSN, boys and girls on every floor with permanent signage, indicating the floor number, as per norms of RPwD Act and guidelines issued by the Board and submit compliance within 3 months on SARAS.
4	The composite lab is not properly equipped or arranged . There are no work stations with proper utilities, storage and seating area. The library is very poorly stocked and seems under sized. No separate reading area for teachers is seen. No maths lab is seen. The school shall upgrade the composite lab, maths lab and library as per SoPs of the Board and submit compliance within 3 months on SARAS.
5	The school shall renew all the mandatory certificates from time to time.
6	The school is directed not to remove the essential document uploaded on mandatory public disclosure of the school website and the YouTube link.
7	The school shall conduct training of its teachers at CoE Pune within 3 months and submit compliance on SARAS.
8	The school shall follow the SoPs of the Board for its labs, library and sports facilities.

In this connection, I am directed to convey approval of the Board to permit increase of sections in the school w.e.f t as per rule 4.8 of Affiliation Bye-Laws and subject to strict adherence to the other provisions of Affiliation and Examination Bye-Laws of the Board & appendix V of Affiliation Bye-Laws as well as the following specific conditions:
